**Abortion**

On January 22, 1973, the U.S. Supreme Court ruled (7-2) that women, in consultation with their physicians, have a constitutionally protected right to have an abortion in the early stages of pregnancy—i.e., before the unborn child can live outside the womb—free from government interference. Interestingly enough, the court ruled that the word “person,” as used in the due process clause of the Fourteenth Amendment (“no state shall deprive any **person** of life, liberty, or property without the due process of the law”), does not include the unborn. This, of course, raises the question of what criteria should be used in determining personhood.

The liberal criteria for determining personhood are as follows: (1) consciousness and capacity to feel pain; (2) developed reasoning; (3) self-motivated activity; (4) capacity to communicate messages; (5) presence of self-concepts and self-awareness. Let me just say here that Ford, my one-year-old baby boy, doesn't meet some of these criteria. Am I to conclude that he's not a person and therefore expendable?

The 1973 Roe v. Wade decision touched on each trimester of a woman's pregnancy. During the first trimester (0-13 weeks) of pregnancy, the decision to abort rests solely with the woman and her doctor. This amounts to abortion on demand. During the second trimester (13-26 weeks), the states were given some choice. They can regulate the abortion procedure to protect maternal health. During the third trimester (26-40 weeks), when the fetus is viable (though for most hospitals in the United States the age of viability is now about 24 weeks), the State can regulate or even prohibit abortion, except when it is necessary for the mother's psychological and physical health (i.e. “therapeutic abortion”). New York's latest abortion law on the anniversary of the Roe v. Wade decision has unsurprisingly ignited a firestorm of controversy.

Despite what the U.S. Supreme Court or one of our state legislatures might say about abortion, Christians give (or should give) precedence to how the Supreme Court of the universe, i.e. God, views this matter. First, God affirms the personhood, or humanity, of both the prenatal and postnatal child (Luke 1:39-45; 2:12, 16). Second, God declares His hatred for “hands that shed innocent blood” (Prov. 6:17; cf. Jer. 22:3; Exod. 21:22-23). On this point, there is warranted debate about what to do when a mother's life is in danger. If taking the life of the unborn child were necessary for saving the mother's life, would this be tantamount to murder? Third, God insists that the body of a mother and the body of her child belong to Him by virtue of His creative (and redemptive) work (Gen. 1:26-27; Psa. 139:13-16; Zech. 12:1; Rom. 12:1-2; 1 Cor. 6:19-20). Some argue that a woman has a right to choose what to do with her own body, as if the unborn child is a part of the woman's body and not his/her own entity. Ultimately, a mother is not “god” over her own body, much less the body of her child. That's God's prerogative, and He has his own expectations of what we should and should not do with our own bodies or to the bodies of others.

So, if you are a Christian in a country where abortion is regularly practiced, what are you to do? First, *pray* for our leaders, our society, and the countless women who are contemplating abortion. Second, *proclaim* not only the spiritual, psychological, and physiological consequences of abortion, but also the good news that forgiveness is possible through Jesus Christ. Third, *persuade* whoever will listen to adopt a Christian worldview that is based on the teachings and principles of Scripture. The one viable hope in this world to end the abortion holocaust is not a fearless politician or president or even a law reversal; it's Jesus residing in changed hearts. Fourth, *provide* a listening ear, open arms, love, support, and even resources to those with whom you come into contact that are contemplating abortion.
