The Standard of Judgment

In *Words We Live By*, Brian Burrell tells of an armed robber named Dennis Lee Curtis who was arrested in 1992 in Rapid City, South Dakota. Curtis apparently had scruples about his thievery. In his wallet, the police found a sheet of paper on which was written the following code:

- 1. I will not kill anyone unless I have to.
- 2. I will take cash and food stamps—no checks.
- 3. I will rob only at night.
- 4. I will not wear a mask.
- 5. I will not rob mini-marts or 7-Eleven stores.
- 6. If I get chased by cops on foot, I will get away. If chased by vehicle, I will not put the lives of innocent civilians on the line.
- 7. I will rob only seven months out of the year.
- 8. I will enjoy robbing from the rich to give to the poor.

Many criminals, not to mention most crime organizations, have their own moral code. Mr. Curtis was no different; he had a sense of morality, but it was flawed. When he stood before the court, he was not judged by the standards he had set for himself but by the higher law of the state.

Similarly, when we stand before the judgment seat of Christ (2 Cor. 5:10; cf. Acts 17:30-31; Rom. 14:10-12), we will not be judged by some code of morality we have written for ourselves. We will be judged by the word of Christ (John 12:48). Consequently, we should study His word, internalize His word, and do our best to obey His word, while relying on His grace that was supplied to us through His sacrifice on our behalf.
