Matthew 7:1 is arguably the most well-known and most abused passage in the Bible: "Judge not, that you be not judged." These words are frequently used defensively. One person will say to someone else in one way or another, "That's a sin; you shouldn't do that." The second person will defend himself by saying, "You can't judge me. Don't you know Jesus said not to judge?" But is this how Jesus intended for this passage to be used? Did He intend for us to use His words in Matthew 7:1 as a shield against rebuke and admonishment? In this article, we'll demonstrate what Jesus was not saying Matthew 7:1. In next week's article, we'll consider what Jesus was saying.

Judgment is demanded when deciding the innocence or guilt of a civilian. Leo Tolstoy believed, based on Matthew 7:1, that "Christ totally forbids the human institution of any law court" and that he "could mean nothing else by those words." But Jesus' prohibition cannot possibly mean the one thing Tolstoy says it must mean, for the context of Matthew 7:1 does not refer to judges in courts of law but rather to the responsibility of individuals to one another. Furthermore, Romans 13:1-7 underscores the authority that the government has in punishing wrongdoers. The idea is that one is first rightfully "judged" to be guilty of some crime before being punished.

Judgment is demanded when distinguishing between good and evil or truth and error. The prohibitive command "judge not" is followed almost immediately by two further commands. First, we are to avoid giving what is holy to dogs or throwing pearls before pigs (Matt. 7:6). The "dogs" and "pigs" represent impenitent unbelievers, while "what is holy" and "pearls" represent the good news. Second, we are to watch out for false prophets (Matt. 7:15-20). It would be impossible to obey either of these commands without using our critical judgment. In order to determine our behavior towards "dogs," "pigs," and "false prophets," we must first be able to recognize them, and in order to do that, we must exercise some critical discernment. Jesus' injunction to "judge not" cannot be understood as a command to suspend our critical faculties in relation to other people or to refuse to discern between good and evil or truth and error.

Judgment is demanded when disciplining a wayward brother or sister in Christ. This is essentially a sub-point to the previous point, and it answers the question we posed in the opening paragraph. If judgment in all its forms is prohibited, then the church would never be able to discipline those who go astray. Take a few moments to read 1 Corinthians 5:1-5. If Matthew 7:1 means what many folks think it means, then what do we do with Paul's teaching here? All the wayward person would have to do in this case is quote Matthew 7:1 and go on his merry way. Without judgment, there could be no discipline, and without discipline, where will this wayward brother in Christ more than likely end up? Sometimes you and I need to be corrected, admonished, or criticized, don't we? I know I do. As God's people, we should want to do what is right; consequently, we should accept criticism or judgment if it is based on the truth of God's Word (cf. Prov. 12:1).

We live in a culture of watered-down tolerance where people foolishly believe that the best thing for them is to be left to their own vices. As Christians, we know that loving others involves speaking the truth in love to them. On the one hand, it is detrimental to our spiritual welfare to use Matthew 7:1 as a defense against all judgment or criticism from others. On the other hand, it is detrimental to our spiritual welfare if everyone around us refuses to confront us with our sin because of an improper understanding and application of Matthew 7:1.
